

Building Construction Industry Payments Act - a framework for unpaid subcontractors to seek arbitration and Subcontractors Charges Act - which allows an unpaid subcontractor to lodge a charge with the Principal before commencing an action to recover against the contractor. Note that the two acts mentioned above cannot be used in conjunction - it is either one or the other.
